Subject: Recognition Certificate for the school under sub-rule (4) of rule 15 of Right of Children to Free and Compulsory Education Rule, 2010 for the purpose of section 18 of Right of Children to Free and Compulsory Education, Act, 2009.

With reference to your application No. JIS/155/24-25 dated 16.08.2024 and subsequent inspection in this regard, I convey the grant for provisional recognition to Jiwrajka International School, Sayli, Silvassa, UT of DNH & DD upto **Class XII**.

The above recognition is subject to the fulfilment of following conditions:

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class XII.
2. The school shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure-I) and the Right of Children to Free and Compulsory Education Rules, 2010 (Annexure-II).
3. The school shall admit students in class I (or in pre-school class, as the case may be) to the extent of 25% of the strength of that class. Children belonging to Weaker Section and Disadvantaged Group in the neighbourhood should be provided free and compulsory elementary education till its completion.
4. The school shall not collect any capitation fee from the child or his or her parent or guardian to any screening procedure.
5. The school shall not deny admission to any child, -
 - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b. On the ground of religion, caste or race, place of birth or any of them.
6. The school shall ensure that, -
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Inclusion of students with disabilities / special need as per provision of the Act.
 - e. The teachers are recruited with minimum qualifications as laid under section 23 (i) of the Act.
 - f. The teachers perform his duties specified under section 24 (1) of the Act.

7. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
8. The school shall maintain the standards and norms as specified in section 19 of the Act.
9. No unrecognized classes shall run within the premises of the school or outside in the name of school.
10. The school building plan must have been approved by the current rules or G.Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
11. The school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860). Or a public trust constituted under any law for the time being in force.
12. The school is not run for profit to any individual, group or association of individuals or any other persons.
13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
14. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the school.
15. The certificates of recognition issued by the department shall be subject to the fulfilment of deficiencies if any pointed out by the department at any stage/ time.
16. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
17. The management shall apply for renewal of recognition three months before the expiry of this order to this District Education Officer, Directorate of Education, UT of DNH & DD
18. The management shall follow the directions issued by the Government/ Department from time to time keeping in view of the safety and security of the children and the overall administration of the school.
19. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.
20. The school management shall have to full responsibility if any court cases arise this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the Department of Education, UT of DNH & DD.
